## I. CALL TO ORDER

Mr. Hall called the meeting to order at 7:34 p.m.

## II. PUBLIC HEARINGS

A. WET#2382(S) ASML – 77 Danbury Road – construction of a 3-story employee parking garage 90 ft. from a wetland and repaying existing parking area 4 ft. from a wetland

Mr. Conklin read the letter from the applicant's agent requesting a continuation on the Public Hearing as the check for the third party consultant has not been received.

### VII. OTHER APPROPRIATE BUSINESS

# A. WET#2387(M) GUERON – 24-30 Cannon Road – install 275-gallon oil tank on cement pad with spill protection cover

Mr. Conklin provided a brief description of the home heating oil spill that occurred earlier in the year and explained that the tank is proposed to be placed in the same location approximately 5 ft. from the river. He noted that this may be an opportunity for the commission to require the tank to be placed in a location further from the river. Mr. Conklin noted that he found this type of application, with a tank over 100 gallons, is deemed to be an intermediate level so he will contact the applicant and ask for further information so the commission can make a determination at a meeting.

Mr. Conklin suggested that this area may not be conducive to home heating oil and stated liquid propane or electric heat may be a better solution. Ms. Craig asked what caused the tank to breach. Mr. Conklin stated that it may have been aging. As the proposed location is in a flood plain, the replacement tank, if requested, may need to be elevated.

### B. Violation – Kelly – 55 Ryders Lane

Mr. Conklin notified the commission of a violation that was discovered this week where understory was cleared in a wetland without a permit. Ms. Craig asked what was removed. Mr. Conklin responded that it was mostly invasives. He was asking the commission what level permit they would like to assign but noted that the regulations state any work in a wetland would be at least an Intermediate Level Permit. The commission agreed that an Intermediate Corrective Action Permit will be required.

## C. Violation – Cross – 105 Old Belden Hill Road

Ms. Craig stated that she drove past this property and work is still occurring in the regulated area. The commission discussed the fine process and confirmed that citations be issued for this willful violation of the Cease & Desist Order.

#### D. Approval of Minutes – April 14, 2016

Ms. Craig MOVED to APPROVE the minutes as drafted, SECONDED by Mr. Andrews, and CARRIED 4-0-0.
