    - MEP Schedule Some work on the fume hoods in the Science Rooms remains. The cabinet unit heaters in the Front Lobby will be completed over Thanksgiving Break. The heating piping has been completed. The system will be filled with water and the heat is scheduled to be turned on by the October 15<sup>th</sup> target date. Mike also reported that considerable work needs to be done on the controls and the

VAV boxes. The balancing of the systems will begin soon and should take 2-3 months.
