Chairwoman Poundstone convened the meeting at 7:00 p.m. and provided a brief update concerning the status of the Plan of Conservation and Development; noting that the public hearing had closed and the purpose of the meeting was to make final edits and possibly vote on adoption of the plan. Chairwoman Poundstone requested consultant Heidi Samokar of Planimetrics, LLC review suggested changes in response to submitted Board of Selectmen comments as well as comments from the public. Ms. Samokar proceeded to discuss recommended changes as outlined in her November 2, 2009 memorandum to the Commission.

Discussion ensued concerning Conservation Strategies. The Commission requested the inclusion of a sidebar defining "greenway". The Commission also requested that language describing appropriate use of the Super 7 highway corridor be amended slightly.

The Commission agreed to omit, in its entirety, language found in item #10. With regard to item #12, the Commission replaced the words "to citizens" with "for residents".

The Commission requested modification to the map entitled "Transportation Plan" found on page 99 of the document to include proposed and desired train stations at Georgetown and Kent Road.

It was recommended that the creation a "drought ordinance" be elevated to a priority #1 classification. Similarly, the Commission requested recommendations found on page 126 pertaining to Cannondale, be elevated to a priority #1 designation.

It was suggested that a statement on page 15 be added to encourage an annual review of the plan as it relates to implementation. Finally, upon recommendations from the Conservation Commission, the Planning and Zoning Commission omitted "Option B" depicting a river walk on the east side of the Norwalk River.

Commissioner Wilson made a motion to approve the 2009 Plan of Conservation and Development with conditions as discussed (see attached copy of conditions), effective January 1, 2010. Commissioner Pratt seconded the motion and the motion was approved unanimously.

Chairwoman Poundstone thanked members of the Commission, town staff and employees of Planimetrics for their hard work and loyal participation throughout the planning process and stated that the plan would serve as a valuable guide for many years to come. The meeting adjourned at 8:00 p.m.
