 - "An elected or appointed official may be removed from office by the Board of Selectmen upon its finding of good and sufficient cause for such removal and after a public hearing before the Board of Selectmen. The official affected by such removal process shall be given notice thereof and an opportunity to appear and be heard at the public hearing before the Board of Selectmen. Willful malfeasance, willful neglect of duty, inability to serve, conviction of a felony or abandonment of office, inter alia, shall constitute cause for

removal. Such removal shall require an affirmative vote of four members of the Board of Selectmen.

- (2) The failure of a member of any elected or appointed board to attend three consecutively scheduled meetings of such board without having given the Chairman or another officer of such board prior notice of such absence with reasons therefor shall be deemed to constitute a cause for removal pursuant to this section."
