 - Revaluation Update Sarah Scacco Sarah Scacco, Assessor for the Town gave an update on the Revaluation (presentation attached).
 - Virtual Net Metering Opportunity Cela Sinay-Bernie- Citrine Power, Jonathan Luiz-Town Administrator, Town of Weston Item tabled.

- 3. Berchem Moses New Retainer Letter and Fee Agreement Ms. Vanderslice reviewed the Berchem Moses engagement and fee agreement for Dec 1 2018 to Nov 30, 2019. The one year agreement corresponds with the Town Attorney term, which ends on Nov 30, 2019. There is no increase in the monthly retainer; excess billing rates are up 4% or an average annual increase of 2%. Town Counsel provided assurance that rates will not increase should the Board decide to reappoint Town Counsel for the 2019/2020 year. Town Counsel will be attending next meeting to provide a litigation update.
- 4. Police Town Campus Owners Representative Recommendation Patti Temple & Dave Waters Co Chairs Building Committee Dave Waters & Patti Temple, Co Chairs of the WPD/Town Hall Campus Building Committee and Chris Burney provided a review of need for and their process for the selection of their recommendation to hire Colliers International as an owner's representative for the Police/Town Campus Building Project. After review, motion made by Mr Clune for the First Selectwoman to work with Town Counsel to execute a contract with Colliers International not to exceed \$40,000 for Phase I. Motion seconded by Ms. McFadden and carried 5-0.
- 5. Proposed Policy on Commencing Foreclosure on Blight Judgment Lien Ms. Vanderslice further reviewed the proposed policy on commencing foreclosure on blight judgment lien as recommended by Attorney Mario Coppola that was discussed at the last BoS meeting. She reviewed the policy as agreed to at the previous meeting. The policy requires the blight enforcement officer to confer with the Board of Selectmen and town attorney about commencing a lien foreclosure action within a year of the filing of the judgment lien. Ms. McFadden suggested options on an additional step she would like in the process. After discussion and no agreement, Ms. Vanderslice stated she would share the discussion with Attorney Coppola for comment.

Informal Hearings with Vision Appraisal

- Vision Appraisal will be conducting informal hearings at Comstock Community Center.
- Contact information for Vision Appraisal to schedule an informal hearing will be on the notice of assessment change.
- Deadline to schedule an informal hearing is January 16, 2019.
- Any taxpayer with questions or concerns is urged to attend an informal hearing.

Informal Hearings with Vision Appraisal

- Informal hearings are essential as they provide an opportunity for any necessary changes to be made prior to the grand list being signed.
- Informal hearings also provide an opportunity for taxpayers to get a better understanding of their new valuation.
- Property owners are urged to compare their new valuations with valuations of similar properties in their area. This information will be available online and in the Assessor's Office once new assessment notices are sent out.

Useful Tools Available

- The Assessor's Office webpage has links to some useful tools for the public to review their new valuations:
 - Access to field cards for all properties located in the Town of Wilton – http://gis.vgsi.com/wiltonct/
 - On Vision Appraisals website there is also a tab labeled 'Sales Search' that will be helpful to find properties that have sold.
 - Access to GIS maps through MapXpress http://wilton.mapxpress.net/

Please note, field cards will <u>not</u> be updated with new assessment information until notices are sent out

Board of Assessment Appeals

- Important things to remember when preparing for a Board of Assessment Appeal Hearing:
 - Be organized and bring copies of whatever materials you will be presenting as they will need to be retained for FOI purposes.
 - New valuations are effective for the October 1, 2018 grand list however they are based on market value as of October 1, 2017.
- Compare valuations of similar properties in your area, comparable sales, or hire an appraiser.
- Review qualified sales that occurred prior to October 1, 2017 of comparable properties.
- Any pictures you have of your property that you feel will support your appeal are always welcome.
